## "TOORMINA GARDENS SHOPPING CENTRE PROMOTION"

## TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 18 years or over who visit Toormina Gardens Shopping Centre during the Promotional Period.
- 3. Employees (and their immediate families) of the Promoter, Toormina Gardens Shopping Centre and agencies associated with this promotion are ineligible to participate. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. - 15. The Promoter's decision is final and no correspondence will be entered into.
- 16. The first valid entry drawn will win one (1) \$1,000 Digital Vault Gift Card ("**Major Prize**"). The winner will be sent the Major Prize via SMS.
